

# Student eligibility for Skills First

This fact sheet explains how you should apply Skills First eligibility rules and includes helpful example scenarios.

## Eligibility requirements

To be eligible for Skills First funding, a student must be:

- an Australian citizen or permanent resident, or a New Zealand citizen
- physically present in Victoria when they're doing training and assessment.

There are limits on how much Skills First-funded training a student can do. This aims to maximise program completions and encourage students to make informed decisions about their training and employment opportunities.

## Volume limits

To maximise program completions and encourage students to make informed decisions about training and employment opportunities, there are **3 limits** on how much Skills First-subsidised training a student can do.

Eligibility requirements are described in the VET Funding Contract (the contract) and the Guidelines About Eligibility (the guidelines).

You must apply the eligibility requirements unless there's an exemption in part C of schedule 1 of the contract or under any special initiatives. To grant an exemption you must follow the requirements of the relevant initiative.

## Example scenarios

These scenarios show examples of how to assess a student's eligibility.

### Example 1 – Mohammed wants to enrol in the Certificate II in Ecology

<p>This calendar year, Mohammed:</p> <ul style="list-style-type: none"><li>• <b>commenced and completed</b> the Certificate II in Food Processing (Skills First subsidised)</li><li>• <b>commenced and completed</b> the Certificate II in Auslan (Skills First subsidised).</li></ul>	<p>Is Mohammed eligible?</p> <ul style="list-style-type: none"><li>• <b>NO.</b> Mohammed has reached the '2 AQF qualifications in a year' limit, so he can't get Skills First funding for any more AQF qualifications this calendar year.</li><li>• However, he is still eligible to enrol in up to 2 Skills First funded skill sets this year.</li></ul>

### Example 2 – Sarah wants to enrol in the Certificate III in Engineering

<p>This calendar year, Sarah:</p> <ul style="list-style-type: none"><li>• <b>continued her training</b> in the Certificate III in Beauty Services that she started <b>last year</b> (Skills First subsidised)</li><li>• <b>commenced</b> the Certificate III in Retail this year (Skills First subsidised).</li></ul> <p>Both programs are still in progress.</p>	<p>Is Sarah eligible?</p> <ul style="list-style-type: none"><li>• <b>NO.</b> Sarah has reached the '2 at a time' limit.</li><li>• <b>However</b>, she can commence the Certificate III in Engineering later in the year if she completes or withdraws from one of her current courses.</li><li>• If this happens, she will not be exceeding the '2 AQF qualifications in a year' limit because she commenced the Certificate III in Beauty Services last year.</li></ul>

### Example 3 – Stefan wants to enrol in the Certificate III in Tourism

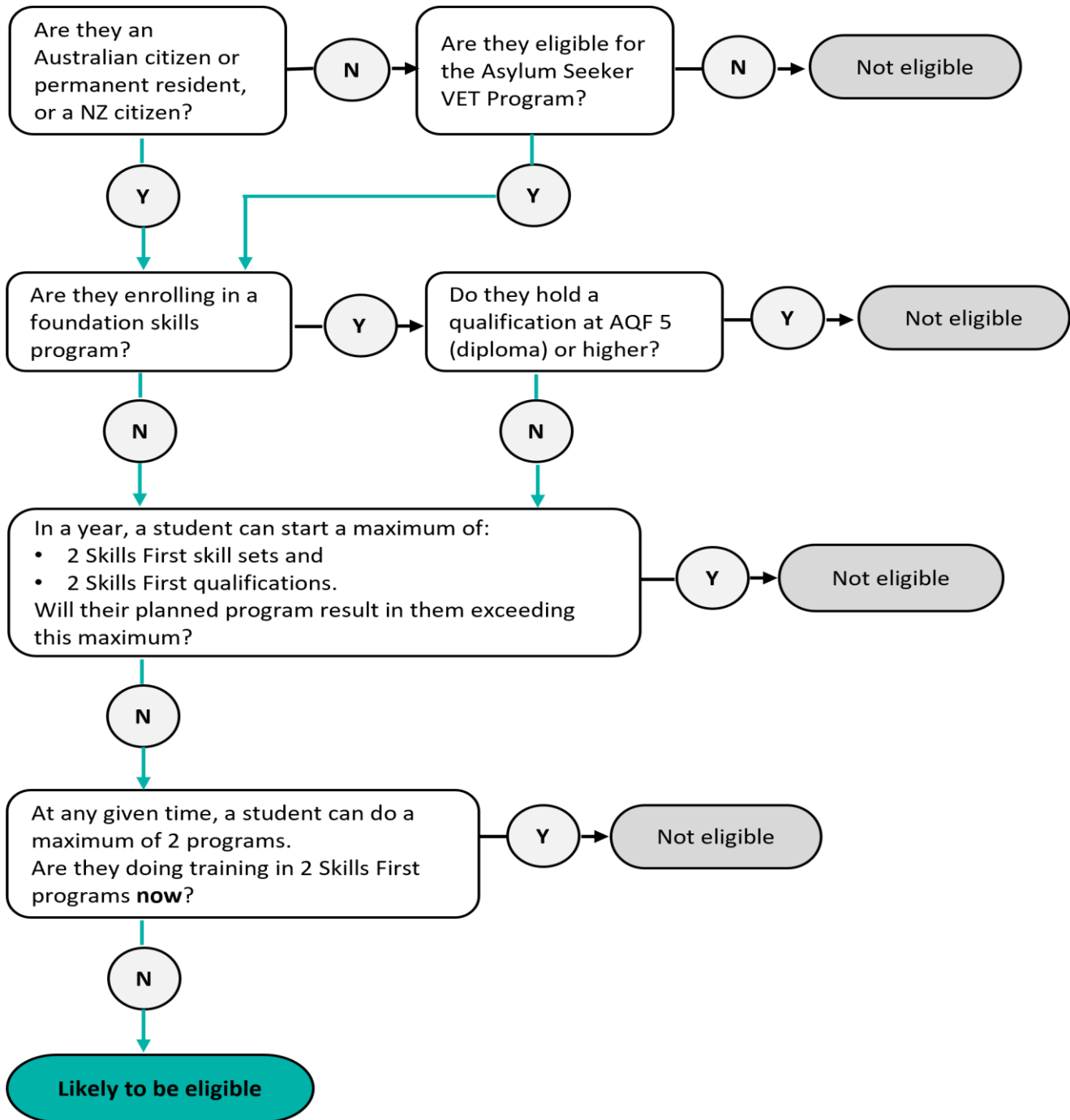
<p>This calendar year, Stefan:</p> <ul style="list-style-type: none"><li>• <b>commenced</b> the Certificate III in Pet Grooming (Skills First subsidised)</li><li>• <b>commenced</b> the Certificate III in Science (fee for service).</li></ul> <p>Both programs are still in progress.</p>	<p>Is Stefan eligible?</p> <ul style="list-style-type: none"><li>• <b>YES.</b> Stefan hasn't reached the '2 in a year' or the 'two at a time' limit, because only one of the programs he commenced this year was Skills First subsidised.</li></ul>

### Example 4 – Nisha wants to enrol in the 'Assist Clients with Medication Skill Set'

<p>This calendar year, Nisha:</p> <ul style="list-style-type: none"><li>• <b>commenced</b> the Certificate II in Health Support Services (Skills First subsidised)</li><li>• <b>commenced</b> the Course in Supporting People with Disability to use Medications (Skills First subsidised).</li></ul> <p>Both programs are still in progress.</p>	<p>Is Nisha eligible?</p> <ul style="list-style-type: none"><li>• <b>NO.</b> Nisha has reached the '2 at a time' limit.</li><li>• However, because Nisha hasn't reached the '2 skill sets in a year' limit, they'd be eligible for the 'Assist Clients with Medication Skill Set' after they either finish or withdraw from one of the other programs.</li></ul>
